Ramadan Focus - Zakaah

A Pre-Ramadan Reminder

Zakaah : A Professional Pre-Ramadan Reminder for Muslim Lawyers & Accountants

As Ramadan approaches, Sha'bān serves as an ideal time for professionals to review their Zakaah obligations with accuracy and intention. Given the nature of our professions — grounded in accountability, compliance, and stewardship — careful calculation and record-keeping are essential.

1 Confirm the Nisāb

Zakaah becomes obligatory once your net Zakaatable assets equal or exceed the Nisāb.

2 Identify Zakaatable Assets and their current value and these to include:

- Cash and bank balances
- Savings and fixed deposits
- Investments (shares, unit trusts, crypto held for trading)
- Business inventory and trade receivables
- Loans receivable (where recovery is expected)
- Gold and silver (including jewellery, subject to scholarly opinion)

3 Deduct Allowable Liabilities

Deduct only short-term and immediately due liabilities, such as:

- Trade creditors
- Tax liabilities currently payable
- Short-term financing obligations
- Essential expenses due at the Zakaah date
(Long-term liabilities not yet due are generally excluded.)

4 Calculate Zakaah Payable

Zakaah is calculated at 2.5% (1/40) of the net Zakaatable amount after deductions.

$$\text{ZAKAAH DUE} = \text{NET ZAKAATABLE ASSETS} \times 2.5\%$$

Professional Note:

Zakaah is payable once a full lunar year (ḥawl) has passed from the date wealth first reached the Nisāb. Consistency in valuation dates and documentation supports both Sharī'ah compliance and sound financial governance.

As professionals entrusted with public confidence, fulfilling Zakaah correctly is not only an act of worship, but a reflection of ethical responsibility and amanah.
